You can find <u>accommodation</u> in one of the many hotels in Dubrovnik (Hotel Imperial is the closest to the centre, but expensive, Hotel Lero is cheaper, and about 1½ kilometer (1 mile) from the Centre. Another popular and very recommendable form is one of the many private accommodations (Room or "Sobe") which are relatively cheap and can be found everywhere. Booking.com is usually a good platform for finding this type of accommodation. Make sure to book well in advantage to get the best price. The IUC also provides cheap but limited accommodation in the building itself.

All <u>meals</u> are taken at restaurants and cafés in town, the conference do not provide any meals. Prices are in the range of 100 – 300 kuna when drinks are included.

The Dubrovnik <u>airport</u> is situated about 20 kilometres South of Dubrovnik and shuttle busses run regularly. The <u>weather</u> in May is normally sunny and 20-25 C, though rain is not impossible.
